The firm's strong culture of mentorship, combined with its open-door policy, creates an environment where we feel comfortable asking questions and seeking guidance at any time.

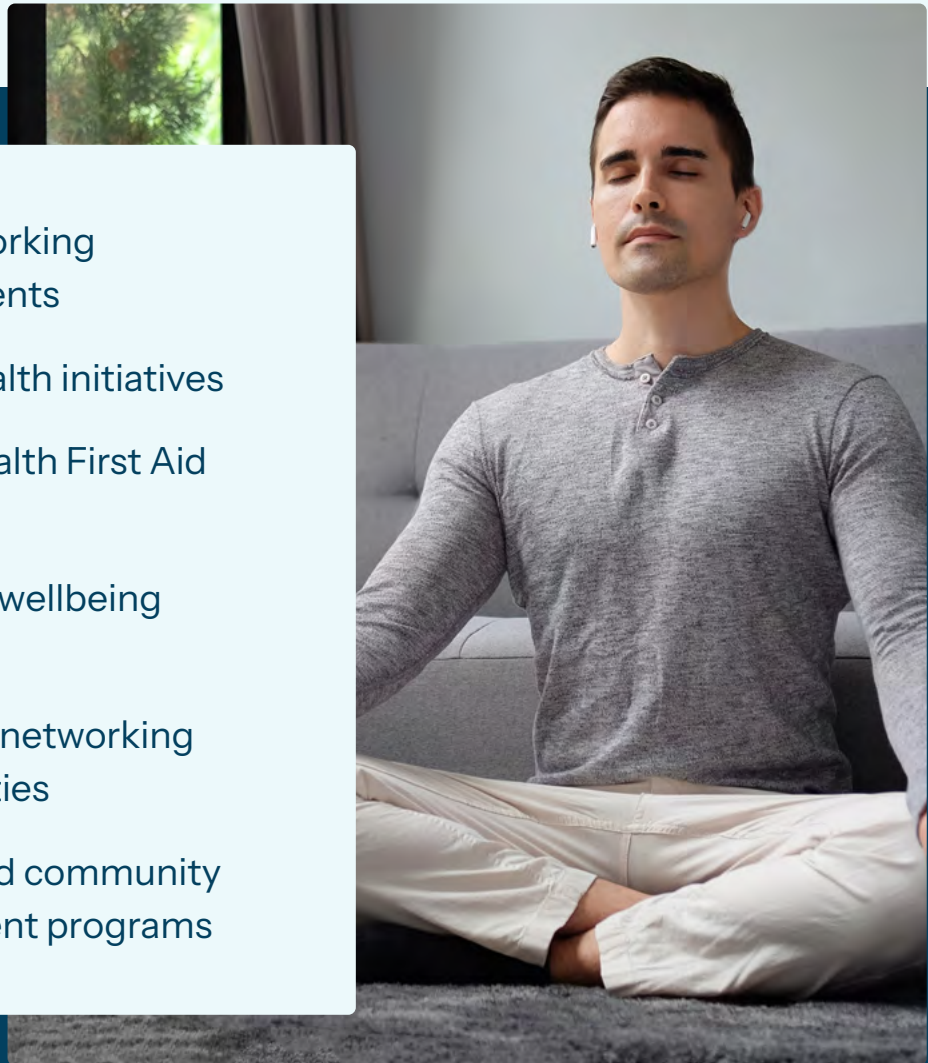


Wellbeing Matters
